Run your clothes wash and dishwasher only when they are full. You can save up to 1,000 gallons a month.

Water plants only when necessary.

Fix leaker tollers and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To checke your full for a leake place a few drops of food coloring in the tank and wait. If it seeps into the toiler bowl without flushing, you have a leake Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.
